介護保険第2号被保険者は40歳以上65歳未満の方です。

端数処理：事業主が、給与から被保険者負担分を控除する場合、被保険者負担分の端数が50銭以下の場合は切り捨てし、50銭を超える場合は切り上げて1円となります。

端数処理：事業主と被保険者の間で特約がある場合は、特約に基づき端数処理をすることができます。

全額事業主負担の子育て拠出金率は、1.5/1000 です。

賞与に係る保険料額は、賞与額から1,000円未満の端数を切り捨てた額(標準賞与額)に保険料を乗じた額です。

標準賞与額の上限は健康保険は年間573万円(4月1日からの累計)、厚生年金と子育て拠出金は月間150万円です。
